

OFFICIAL RULES CHARITABLE GOLF CART RAFFLE

VOID WHERE PROHIBITED BY LAW.

Eligibility:

Participants must be a U.S. resident and at least 18 years of age at the time the raffle begins. The Charitable Golf Cart Raffle ("Raffle") is void outside the United States, or where prohibited or restricted by law.

This Raffle is sponsored by YMCA of Greater Kansas City ("Sponsor"). All YMCA of Greater Kansas City employees and their immediate families are not eligible to participate in the Raffle or to win any prizes.

Any Raffle entries received from an ineligible participant will be disqualified. By participating in this Raffle, participants accept and agree to be bound by these rules and the decisions of Sponsor, which shall be final on all matters. Sponsor reserves the right to modify the rules of the Raffle in any way at any time, subject to state or federal law.

Raffle Period:

The Raffle begins on Monday, May 5, 2025, 7am, and ends on Monday, June 16, 2025, 2pm ("Raffle Period"). All Raffle tickets must be purchased during the Raffle Period to be eligible.

Raffle Purpose:

All net proceeds from the Raffle will be applied to the YMCA Family Center Annual Campaign, which is a mission-driven program in which Sponsor provides financial assistance to people in need to help them afford and participate in YMCA activities.

How To Participate:

You can participate in the Raffle by scanning the Raffle QR Code available at the Parkville YMCA facility, the Platte City YMCA facility, and the Sponsor website, and purchasing a Raffle ticket. The cost of each Raffle ticket is \$100.00. A total of 250 Raffle tickets will be available. There is no limit on the number of Raffle tickets that a person may purchase. Each Raffle ticket will include Sponsor's name; the name of the Raffle, the date, time, and location of the Raffle drawing; the price of the Raffle ticket; a statement indicating that Raffle participants need not be present to win; and a unique sequential identification number on the Raffle ticket and the Raffle ticket stub.

Sponsor is not responsible for lost, misdirected, late, unsent, incomplete, illegible or unintelligible attempts to purchase a Raffle ticket, whether caused by the participant or by any of the equipment or programming associated with or utilized in this Raffle, or by any technical or human error that may occur in the transmittal of any Raffle ticket or the processing of any function on the participant's computer system. Participant must notify Sponsor of any changed contact information within the Raffle Period to remain eligible to win based on information used to purchase a Raffle ticket. Sponsor reserves the right, in its





sole discretion, to disqualify any individual found to be tampering with the purchase process or the operation of the Raffle; to be acting in violation of these rules; or to be acting with intent to annoy, abuse, threaten or harass any other person.

Prize and Selection of Winner:

The prize is a Custom Golf Cart with a Fair Market Value of \$8,695.00 ("Prize"). Each Raffle participant will receive one chance to win the Prize per purchased Raffle ticket. Each Raffle ticket will have an equal opportunity to win. The chances of winning depend on the number of Raffle tickets sold. No transfer, assignment, cash redemption or substitution of any prize is permitted, except by Sponsor due to prize availability and then with a prize of equal or greater value.

Winner will be selected in a random drawing on Monday, June 16, 2025, 2pm, during the Family Center Golf Tournament to be held at Staley Farms Golf Club. Winner need not be present to win. Sponsor will notify Winner by email and phone call.

Winner must respond within five (5) calendar days of being notified or the prize may be forfeited and another Raffle participant chosen. By participating Winner certifies that he or she complies with these Raffle Rules, and agrees to allow Sponsor, anyone acting on behalf of Sponsor, or its respective licensees, successors and assigns to, where permitted by law, without any further notice, review, or consent to print, publish, broadcast, distribute, and use, worldwide in any media, winner's entry, including, without limitation, the entry and winner's name, portrait, picture, voice, likeness, image or statements about the Raffle, and biographical information as news, publicity or information and for trade, advertising, public relations and promotional purposes without any further compensation. sign a liability and publicity release, allowing Sponsor to use his or her information for advertising or other purposes. Failure to complete these forms may result in forfeiture of the prize. In the event that the potential winner is disqualified for any reason, Sponsor may select an alternate potential winner by random drawing from among all remaining Raffle tickets.

Winner is solely responsible for all applicable federal, state or provincial, and local taxes and any expenses associated with any prizes. Sponsor will issue IRS Form W-2G to Winner and report the prize value to the Internal Revenue Service. Winner will be required to complete and submit any paperwork deemed necessary to for tax reporting purposes and to pay Sponsor all required tax withholding amount on the Prize. Winner should consult a tax advisor to ensure that he/she timely pays all applicable taxes.

Sponsor reserves the right, in its sole discretion, to modify, terminate, or suspend this Raffle should viruses, bugs, unauthorized human intervention or other causes beyond Sponsor's control corrupt or impair the administration, security or fairness of the Raffle. Sponsor is not responsible for any human or technological error that may occur in the processing of the Raffle nor are they responsible for any error, omission, interruption, deletion, defect, communications line failure, theft or destruction of, unauthorized access to, delay in operation, transmission, or distribution of, or alteration of entries, whether caused by the sender, any of the equipment or programming associated with or utilized in this Raffle, or otherwise.
